## ASSUMPTION OF RISK, RELEASE AND WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

PLEASE READ THE FOLLOWING CAREFULLY AND IF YOU HAVE ANY QUESTIONS, PLEASE ASK THEM BEFORE SIGNING THIS DOCUMENT.

In consideration of participating in Marshall-Putnam Fair Kids' Color Run for CreatiVets on July 15, 2025, I state that I understand the nature of this event and that I am in proper physical condition to participate in such activity. I acknowledge that if I believe that conditions are unsafe, I will immediately discontinue participation in the activity. I willingly and voluntarily agree to the following, or if applicable, as guardian of the participant, I voluntarily execute this Agreement on behalf of my ward and agree to the following:

<u>Assumption of Risk:</u> I understand that this activity I will participate in may be dangerous or have risks. These risks may include serious bodily injury, including permanent disability, paralysis, and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or other risks not known to me or not readily foreseeable at this time. I assume full and sole responsibility for any injuries, costs, and/or damages I incur as a result of my participation in this activity.

Medical Condition: I declare that I am physically capable of participating in this activity.

<u>Waiver, Release, and Indemnification:</u> I release, waive, discharge and hold harmless Marshall-Putnam Fair Association and its directors, employees, volunteers, stockholders, other participants, sponsors, and the CreatiVets, from any and all liability, claims, demands, action or causes of action arising out of or related to any loss, destruction, damage or injury, including death, that may be sustained by me or any personal property belonging to me, which may result from participation in this activity. I understand that this Agreement also binds my spouse, heirs, executors, administrators, and assigns.
